22nd November On 1963, John F Kennedy was assassinated in Dealey Plaza, Dallas. We all know the story; anyone interested will have watched the Zapruder 1 film of the assassination hundred times. There is the haunting image of Jackie, shown right, where she later said that she was reaching onto the trunk of the car because she had seen the back of her husband's head blown off....



So surely we know, over 50 years later what happened that day.....don't we? No, we don't. That photo starts the hares running because Lee Harvey Oswald was *behind* the car not in front of it, so even if he could have fired all of the shots (which now seems unlikely) it can't explain how the *back* of JFK's head could be blown off not the front.

In addition, nobody really disputes at this point that it was this shot that killed JFK and if that is the case, whoever killed him, it was probably not Oswald.

One of the other iconic photos of that day is the picture of the "grassy knoll" (left). A policeman running towards the sound of gunfire and the couple near the road lying over their children to shelter them from the shots coming from behind them; in other words from the *opposite direction* to the book depositary from where Oswald was supposed to have been shooting.

The Warren Commission Investigates



The original commission set up to investigate the assassination of JFK under Chief Justice Earl Warren reported to then President Lyndon B Johnson on September 24th 1964. The report ran to 888 pages and concluded "... that President Kennedy was assassinated by Lee Harvey Oswald Oswald and that entirely alone." Students of history will know that Oswald was never tried for the crime but was himself shot by Jack Ruby two days after his arrest: "I did it for Jackie", Ruby said. The

Warren Commission concluded that Jack Ruby also "acted alone" when he killed Oswald.

Ruby was tried and convicted of murdering Oswald and sentenced to death. You might think that it was hard for him *not* to be convicted given that he had shot Oswald on national television but in fact the conviction was subsequently overturned due to the stupidity of the prosecutors². Before he could be re-tried he died of cancer.

So that's it? The president of the United States is assassinated...AND THAT IS IT???

For quite some time it was and although the alt-press of the day ran wild the conventional media toed the party line and in the absence of the Internet there was no mass distribution of information.

Finally, in 1976 the "Select Committee on Assassinations" (yes, it really was called that) concluded: "The Committee believes, on the basis of evidence available to it, that President Kennedy was assassinated as a result of a conspiracy. The Committee is unable to identify the other gunmen or the extent of that conspiracy". So that totally trashes the Warren commission's "Oswald acted alone" conclusion.

² Instead of going for the slam-dunk conviction of "murder without malice" (equal to manslaughter) the prosecution used a "confession" which was inadmissible and tried to claim he was mentally unstable.

But all the information is available, right? I mean, why withhold it?

Well, actually no...the CIA reports and the FBI reports were only "selectively" provided to the Warren Commission. It was not until the **Assassination Records Review Board** "ARRB", which was set up by the **President John F. Kennedy Assassination Records Collection Act** of 1992, actually intervened and said: this has got to stop, all the information should be released. But even then the CIA and FBI objected to the release of the data so the ARRB set a longstop date of 25 yeas more for the release of *all* the papers. That date is next Thursday, 26th October 2017. So who has the power to stop that release? And whose papers are they?

There was a caveat placed on the release of these papers that either the CIA or FBI could object to the release on the grounds of national security. However the ARRB had the final say as it also stated that the President could overrule any such objection.

Of the remaining unreleased papers there are some redacted pages of the Warren Commission, which are mostly black marker, there are a plethora of papers from various government departments **but the killer** is that two thirds of the 35,000 papers are from the CIA and the FBI.

Let me repeat that so that you get this completely clear: over 66% of the papers which have been held back since 1963, initially from the Warren Commission and then from various other investigations AND THEN from the American public (and you) are those controlled by the FBI and the CIA and these almost certainly relate to the activities of those organizations at the time of the assassination.

So who might be in the frame as a result of the release of the papers?³

The CIA was working with the Mafia on the assassination of Castro. Both Ruby and Oswald had Mafia connections and Oswald had worked for the CIA. The former head of the CIA, Alan Foster Dulles, who was fired by JFK, was on the Warren Commission. One of JFK's memorable quotes: "I want to shatter the CIA into a thousand pieces and scatter it to the winds".

In tape recordings made with Arthur Schlesinger in 1964, Jackie Kennedy places Lyndon Johnson as one of the conspirators along with the "Military Industrial complex" warned against by Eisenhower. Johnson presided over a massive military build up and expansion of the US war in South East Asia. In fact the US has been at war somewhere ever since.

While he was Attorney General Bobby Kennedy relentlessly pursued the Mafia and the corrupt unions. By 1963 he had brought literally thousands of prosecutions. Although he served another year as Attorney General under Johnson the campaign against the Mafia ended with his brother's assassination.

So last Wednesday, 18th October 2017, the CIA formally objected to President Trump asking that no further records be released.
